Treasurer's
Report

The Treasurer's report was received on the motion of Messrs. Margetts and Bishop.

The report showed Credit Balances of £39/10/4 in the Welfare Account, £209/2/5 in the General Account and a Deposit of £300 in Commonwealth Security Bonds. Account outstanding amounting to approximately £77.

The Reunion resulted in a loss of approximately £7/18/9.

The attendance was 280. Subscriptions for this year were £56/5/- as against £68/5/- for last year. We have 266 members as against this time last year of 158, last year finished with 289 members.

General

A special vote of thanks was passed to the Sub-Committees for their excellent work on Reunion night. Moved by Mr. Macindoe, seconded by Mr. Bishop.

Mr. Bishop moved, and Mr. Margetts seconded, that Mr. Rosenberg be appointed to fill the vacancy on the Welfare Sub-Committee.

The Welfare Sub-Committee reported that £10 had been paid to Mr. A. Kennedy, The General Committee Meeting fully endorsed this action.

The following were elected members of the Welfare and Rehabilitation Committee for the ensuing year. Messrs. Jorgenson, Macindoe, Rosenberg & Margetts.

A Sub-Committee was formed for the purpose of compiling and distributing a Bulletin. Members of this Sub-Committee being Messrs. Rosenberg, ~~McMillan~~ and Kerr.

The Secretary was instructed to confer with the Treasurer re alteration to Bank Authority.

The Secretary was instructed to make enquiries re the hire of a hall for next year's Reunion.

The Lower Melbourne Town Hall and several Drill Halls were mentioned as being most suitable.

A Social Sub-Committee, with full power to engage a hall for next year's reunion was formed; to consist of the following members. Messrs. Tullock, Jorgenson, Macindoe, Rhoden and Kerr.
